Mayor opens public hearing for 2011 Village Budget at 7:08 pm

Present: Mayor Miccio, Deputy Mayor Phillips, Trustees LaDue and Ferrara, Village Treasurer/Deputy Clerk Jennifer Ryan, Trustee Delgado absent

Budget discussion

No public present

Mayor closes the public hearing for the budget and opens the workshop meeting

Mayor reads abstracts as follows:

Sewer \$23,252.63

Water \$8,326.89

General \$19,701.35

Mayor entertains motion to approve abstracts as read, So Move, Trustee Ferrara, Seconded, Trustee LaDue, discussion, none, all in favor, Aye.

Trustee Ferrara moves to approve the minutes from the March 21st and March 24th meetings, Seconded Trustee LaDue, discussion, none, all in favor, Aye.

Mayor reads resolution regarding Village of Fishkill Election and entertains motion to accept as read, so Move Deputy Mayor Phillips, Seconded, Trustee Ferrara, discussion, none, all in favor, Aye.

Deputy Mayor Phillips moves to allow Daniel Kalbfus hold his piano recital at the Village Hall, Seconded, Trustee LaDue, discussion, none, all in favor, Aye.

Deputy Mayor Phillips makes the motion whereas by law the salaries for elected officials can only be raised or lowered during the time when the majority of the positions are up for election in the coming year and, whereas the office of Mayor and two Trustees will take place in the election this coming June for 2011-12 and 2012-13, that the salary for the Mayor be reduced from \$12,000 to \$10,000, the Trustees from \$8,000 to \$6,000, Justice from \$8,500 to \$6,500 and the Acting Justice from \$6,500 to \$5,500, Seconded Trustee Ferrara, discussion, none, all in favor, Aye.

Trustee LaDue moves to approve the 2011-2012 budget as presented, Seconded, Deputy Mayor Phillips, discussion, none, all in favor, Aye.

Trustee LaDue reads ambulance report

Mayor entertains motion to set a public hearing for the amendment to the Local Law regarding cabarets for April 18, 2011 at 7pm, So Move, Deputy Mayor Phillips, Seconded, Trustee LaDue, discussion, none, all in favor, Aye.

Trustee LaDue moves to adjourn, Seconded, Trustee Ferrara, Discussion, none, all in favor, Aye. Meeting adjourned at 8:00 pm
